TEXAS BOARD OF VETERINARY MEDICAL EXAMINERS BOARD MEETING MINUTES July 02, 2019

The Texas Board of Veterinary Medical Examiners met for a scheduled meeting on Tuesday, April 09, 2019 at 10:00 a.m. in Room #2-225 of the William P. Hobby, Jr. Building, 333 Guadalupe, Austin, Travis County, Texas.

Agenda Item 1. Full Board Call to Order, Roll Call.

Jessica Quillivan, DVM, Board President, called the meeting to order at 10:00 a.m. Board Members present were Jessica Quillivan; Mr. Keith Pardue, Vice President; Lynn Criner, DVM, Secretary; Carlos Chacon; Samantha Mixon, DVM; Michael White, DVM; Randy Skaggs, DVM; and Sue Allen, LVT. Agenda Item 2. Consideration and Approval of the April 09, 2019 Minutes.

Dr. Quillivan noted that two items from the April 09, 2019 were left off the agenda for the July 02, 2019 board meeting.
