Agenda Item 3. Citizen Comments

- a. Judy Santerre. rural changes sent in my Jody Ware, DVM also commended the Board for being more transparent.
- n. Trent Hightower with Texas Veterinary Medical Association, commented on proposed rule changes; the honesty and integrity and fair dealing rule they submitted making sure that veterinarians only perform procedures with the consent of the owner. He wants to ensure that this is worded very clearly as he things it doesn't quite do that, yet. Re: record keeping, it's too long to understand. Proposal based on Ohio. Practitioners said is problematic and too broad in scope. Complete records on

surgery, be detailed, etc. Change to the rules that require or allow docs to share records is a good rule. Suggested we develop Ohio's rules.

Agenda Item 4. Agency Reports

Mike Tacker (Acting ED) . . Hired part-time attorney, Brittany. Keving McDonald in enforcement hired investigator for Dallas region. New hire is a 15-year vet tech. . Kevin McDonald has stepped in as Interim Enforcement Supervisor while Mike has been acting as Interim Executive Director. .

Reorganization on Legal Team and Licensing.

Texas Parks and Wildlife has filed 80 cases on individuals practicing veterinary medicine without a license in Uvalde county.

The previous two weeks have been busy dealing with the office move; boxing everything up. The move took place July 12th. Agency inventory was completed.

IT has requested from the governor's office to fund some new software. The dental board is going to share their IT person with TBVME on a 10-20% basis.

Furniture has been ordered for the new building.

Storage room has been cleared out.

Purchased and received an extension to our server.

1. Reports

Strategic plan was due in June. It's in progress. Very lengthy report. Project next 5 years. Hope to be completed by the end of July.

LAR due July 29th.

House Bill 40.18 is due October 1st. LBB reports to ensure compliance, are due September 30 and Performance Measures are in the process of being caught up.

FY 22 budget has been reviewed.

Re-instituted collecting for open records and collecting for CE approvals, as all of that had been shut down, previously.

Preparing for Dr. Gola's orientation training.

Performance appraisals are due July 15th; 75% of them are already done. Looking at merits for employees who have gone above and beyond. We've been coded for 3 employees within the last week.

Update on move to new building.

Mr. Pardue commended the board for it's hard work.

July 7th and be back up on the 8th. .

With so many agencies moving from the Hobby Building, that's a lot of servers at once.

Mr. Tacker added that we do have an action plan we'll discuss later on technology.

Mr. Hargis gave legal report. We have 428 cases in backlog. 435 total. However, we project by, if everything is approved, that would reduce the total amount by 100 cases. Got the new legal team on board. Passing out responsibilities to new legal team which will reduce case rate even more; by another 100 cases by October. Benchmark number is 235 cases. Just a projection.

Since mid-June, received 66 open records request for the legal department. '.

Ms. Whitehead asked in re: to the 171 cases...how old some of the cases. Mr. Hargis informed that it goes back to maybe twothree years, approximately. Jerod spoke about compliance. 33 members are under compliance per the Agreed Orders.

The fingerprinting program implemented in 2018, now has 13,181 fingerprints to look through. 789 have a criminal history which details/info has been requested.

SOAH cases: 19 have been resolved in the last 5 weeks. 13 Agreed Orders have been signed and 2 are set to be dismissed in October.

Wanda Bennet spoke for Licensing: 10,536 DVMs, 57 DVM Specialists, 10 DVM temporary, 2,424 LVTs and 61 Equine Dental Providers, which is total of 13,088 licenses.

Between June 1 and July 7, 85 applications were processed.

The finance team has helped out as it was 45 days before we initially reviewed. That time is decreasing to 30-35 days.

A part-time Licensing Specialist is being brought in.

It takes 1-2 days once one has passed the state exam to get their license.

Mike Tacker spoke on Enforcement. There have been 315 complaints in 2022, so far. 162 cases are under investigation.

The medical review process – there are 90 cases in the queue. Dr. Criner, Dr. White and Dr. Skaggs review most of them.

Agenda Item 5. Discussion of and Possible Action Regarding Rules

Dr. Mixon mentioned Contents are being updated to keep up with advances ad increased standards. .

573.27 has been reworked and will have the following sentence: "Licensee shall conduct their practice with honesty, integrity and fair dealing. Unless otherwise provided for in law, licensees shall obtain consent before performing a procedure."

Dr. Criner motioned to approve the posting of Rule Amendment regarding Rule 573.27 to the Texas Register, pending legal review

Ms. Raquel Olivier seconded the motion

Motion passed.

Regarding Adoption of Veterinarian Patient Record Keeping Rule Amendment 573.52

Dr. White discussed wanting to add the words "legible' and "species" to the rule

Dr. Mixon we can the words "legible" and "species."

Ms. White motioned to adopt above Rule amendment Veterinary Patient Record Keeping changed with adding "legible" in front "written" under subsection (a) and added "species" back into subsection (a)(2), pending legal review

Dr. Criner and Dr. Mixon seconded the motion

Motion passed

With respect to amendment to Informal Conference Rule 575.29

Dr. Mixon discussed Rule amendment for Informal Conferences: (rule 575.29) Nothing was changed, but language was added. Vets need more clarification on what the Board expects coming into Informal Conferences.

Dr. Criner motioned to post rule amendment 575.29 Informal Conference to the Texas Register after approval from legal

With Respect the new proposed Rule Veterinarian Technician Designation 571.18

Dr. Mixon discussed

Vet Tech 801.002 Texas Legislative Act – vet tech MUST be licensed. Pursuant to 571.18. All other employees of vet's office can use veterinary assistant. Sue Allen spoke up on this matter. It's been a "heated argument" across multiple states.

Dr. White distinguished differences in his opinion on what is a veterinary assistant and a licensed veterinary technician

Dr. Golla discussed concerns with the proposed Rule 571.18 and he is worried about push back from people that have been technician for years.

Dr. Criner motioned for rule 571.18 to be posted to the Texas Register for comment after legal review.

Ms. Whitehead Seconded

The motion passed.
